





- Storm water piping repairs will be an ongoing process and repairs will continued to be addressed.




# **BMP** Repairs

#### **Gilley Construction working repairs:**

- Repair sinkhole at east corner of BMP
- Repair/regrade spillway to ensure proper drain flowpath
- Total cost \$11,850
- Schedule tree removal for future date (potentially 2025) – approx. \$33,000






# **BMP Repairs**

#### **Rosenbaum Fence Company working repairs:**

- Repair all leaning posts
- Straighten top coil wire
- Remove all barbed wire
- Replace rear entry gate
- Replace approx. 150' of fence material
- Total cost \$9,075




